3. Consider a proposed Final Plat of Alex Taylor Addition being a 1.496-acre tract of land out of Section 1, Block 40, T-2-S, T&P RR Co. Survey, Midland County, Texas. (Generally located on the west side of Business I-20 and approximately 2,733-feet west of Tradewinds Boulevard. - ETJ, Extraterritorial Jurisdiction)
4. Consider a proposed Preliminary Plat of Mustang Addition, being a 10.20-acre tract of land out of Section 25, Block 39, T-2-S, T&P RR Co. Survey, Midland County, Texas. Generally located southwest of the intersection of E. County Road 140 and FM 715 - (ETJ, Extraterritorial Jurisdiction)
