- o I have been made aware of and understand the City's enforcement policy specified in Midland Municipal Code Title 8, Chapter 6 and Title 1, Chapter 3.
- o I have been provided a copy of Landfill Rules and Policies, and agree to abide by the requirements specified in that document.
