LICENSE REQUIREMENTS

1. A COPY OF TEXAS SALES AND USE TAX PERMIT MUST BE PROVIDED (not just the number)
2. If selling consumable goods – A copy of a Mobile Vendor’s Health Permit must accompany this application. Health Permits can be obtained by contacting the Health Department at 3301 W Illinois Ave #22, (432) 681-7613
3. License Fee is \$4.00, each person must fill out their own application
4. **LICENSE EXPIRES 6 MONTHS FROM DATE OF APPLICATION**
5. If requested by a customer, the peddler/solicitor **MUST** provide the name, address and phone number for themselves and/or the name, address and phone number of the business on whose behalf the solicitation is being made
6. If a residence has a sign stating **NO PEDDLER, NO SOLICITORS** or words of similar import in public view, you are not to solicit this residence
7. Hours for Door to Door Solicitation are as follows:
April 2nd through October 31st: 10 a.m. to 8 p.m.
November 1st through April 1st: 10 a.m. until 7:30 p.m.
